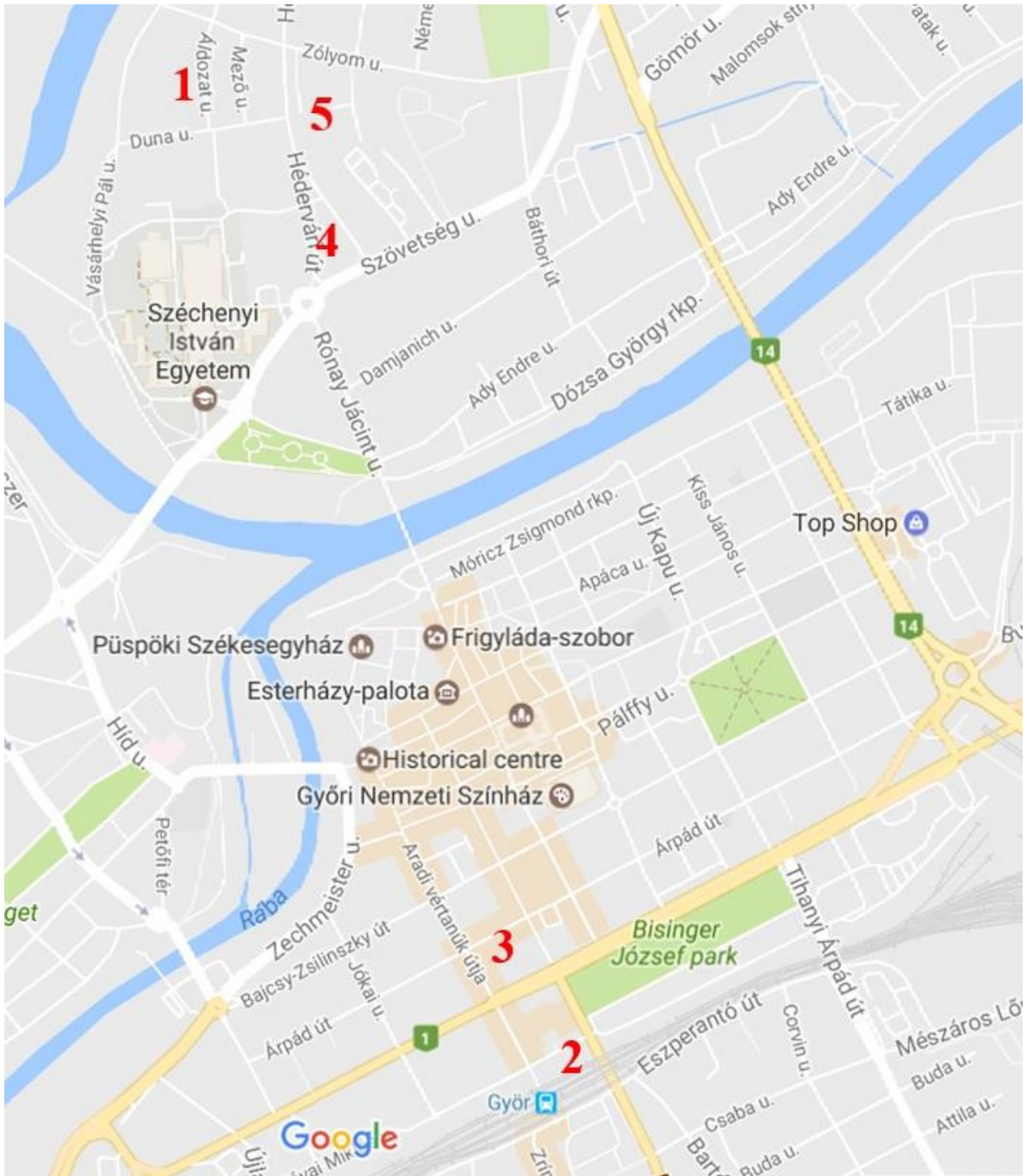
You can access the Faculty from the train station (No. 2)

- by local bus lines 2B, 11, 19 and CITY from the bus stop “Aradi vertanúk útja” (No. 3) to “Széchenyi István Egyetem” (No. 4). Tickets are available in ticket machines for 250 HUF (cash and credit cards are accepted). The “CITY” bus is free of charge.
- by taxi (estimated fare: 1600-2000 HUF)
- by walk (approx. 20-25 minutes).
